# The Phase 1 Development Vision

**The Upcoming Goal:** To eliminate physical file movement for scheduled hearings by bringing all necessary case data directly to the Judge's digital dashboard.

**The Development Strategy:** API-driven interoperability. We are actively designing this system to pull data from established national platforms (CIS, Napix API and e-Filing) into a unified judicial interface, rather than building isolated software.
